COMMITTEE COMPOSITION

- Total contribution of \$5,000. Includes a minimum contribution of \$2,500 to IAPAC for political support and \$2,500 to PAAIA for advocacy support.
- Committee will be made of Democratic, Republican, and Independent donors who have a track record of supporting candidates for public office or are interested in participating in the electioneering process.
- Committee members must be attuned to and supportive of PAAIA's mission and policy initiatives.
